

## **Terms & Conditions**

**Exhibition** means Autorama 2025, to be held 3-5 October 2025.

Organiser means Special Interest Vehicle Events Ltd (SIVENTS)

**Exhibitor** means the person or entity who has applied to exhibit at the Exhibition and includes agents, servants, employees or representatives of the Exhibitor.

**Venue/ Venue Authority** means the Mystery Creek Events Centre.

#### Genera

The Exhibitor agrees that The Organiser has the right to adopt, amend, interpret and enforce all Exhibition terms, rules, regulations and plans with respect to delivering a good event for all participants. This includes but not limited to those regarding the kind, nature, and eligibility of Exhibitors, exhibits and the promotional marketing activities of Exhibitors.

Exhibitors cannot tout for business in the walkways or other public spaces, in another company's stand, or in contravention of any Exhibition term or rules.

Responses to a breach includes but not limited to: Exhibitor expulsion, stand removal, closing off of stand or removing power and or lighting.

The Organiser decisions on all matters shall be final.

The Organiser reserves the right at any time and from time to time to delete, vary or amend any of the Terms and Conditions. The Organiser shall not be liable to the Exhibitor or contractors in respect of claims arising under this contract or in relation to the Exhibition.

## **Conditions of Participation**

Autorama 2025 is an automotive only event. If Exhibitors have any doubt about their products or services not meeting this criteria please contact the Organiser.

The Organiser is under no obligation to accept any application and reserves the right to decline any application at its own discretion.

The Organiser reserves the right to remove any person or exhibit from the site. Any costs incurred by the Organiser are recoverable from the Exhibitor.

The Organiser will not be liable for any loss, including consequential loss, sustained by the Exhibitor as a result of any action taken by the Organiser before, during or after the exhibition.

The Organiser reserves the right to allocate sites, change locations or hall layouts and pricing as required for the success of the Exhibition.

Exhibitors must use the business name provided by them in their application.

The Exhibitor represents that it has full authority necessary to display and sell its products at the exhibition.

The Exhibitor agrees that the Organiser may request, or arrange, the removal of any exhibits that it determines are of a disruptive, objectionable or inappropriate nature. Costs of such removal will be at the expense of the Exhibitor.

All Exhibitors can only use the official contractor(s) appointed by the Organiser/ Venue Authority. This includes but not limited to, Electrical, Lighting and site (Panel) construction.

Exhibitors agree to make the payment for any late fee or charges that are incurred by the Organiser to recover any outstanding balance of payment. If due payments remain unpaid the Organiser may terminate the contract in writing at any time after payment due dates. No refund of any monies occurs.

Set up of the Exhibitors stand must be completed by the specified event opening time. The exhibit must not be removed before the specified event finishing time.

### Insurance, Liability and Security

Exhibitors must make provision for appropriate and applicable insurance cover including but not limited to Public Liability, fire, theft or damage. Neither The Organiser nor the Venue Authority accepts any responsibility/liability for any loss or damage whatsoever affecting Exhibitors and contractors including property damage, consequential loss, loss of revenue, personal or loss of income due to any actions taken by The Organiser.

Exhibitors are liable for any damage they cause to the venue/grounds or exhibition spaces. It shall be the express responsibility of each Exhibitor to ensure that their exhibit complies in all respects with such legal and local government requirements as may be in force at the time of Autorama 2025. All exhibitors must comply with all provisions of the Health and Safety at work Act 2015.

Any Exhibitor supplied electrical wiring/components must comply with current electrical standards. Any equipment, which will be plugged into venue power, must carry a current "Test & Tag" label.

A security service is provided after hours beginning on Pack In dates, and, during event opening hours. However, all stands, equipment and exhibits are at the sole risk of the Exhibitor.

### Cancellation

If sites are cancelled by the Exhibitor all monies paid and owed at the point of cancellation will be forfeited. If a site is resold, the sale price will be refunded. A site may be transferred to another exhibitor as approved by the Organiser.

The Organiser shall have no responsibility, to Exhibitors or sponsors, whatsoever for any matter or thing resulting from acts of God, including without limitation, fire, flood, earthquakes, hurricanes and tornadoes, or other events beyond the parties' control, including without limitation war, government regulation, terrorism, disaster, strikes, civil disorder or infectious disease: except that if such events prevent the exhibition from proceeding, The Organiser shall return to the exhibitor payments made after deducting a pro-rata share of expenses incurred in conjunction with Autorama 2025.

## **Subletting of Sites**

Exhibitors may not sublet, sublease or share sites in any capacity. This includes displaying any advertising or signage not directly applicable to the Exhibitor on that stand.

Selling of Food or Beverages Preparing, selling or giveaway samples of food or beverages is not permitted.

### Privacy

The Exhibitor acknowledges that the Organiser will pass on information about the Exhibitor to stand contractors and/or promotional organisations prior to, during and after the event. The exhibitor

shall inform the Organiser if there is an objection to the transfer of information to third parties.

# **Governing Law**

This Terms & Conditions Contract for Exhibitors' shall be governed by and construed in all respects in accordance with the laws of New Zealand and the Exhibitor irrevocably submits to the exclusive jurisdiction of the New Zealand Courts.
