### TERMS AND CONDITIONS

1. Application acceptance is at the sole discretion of the show organisers. No correspondence will be entered into. Entrants will be advised of Acceptance or other no later than 30 days prior to the event.
2. No vehicle substitutions unless agreed with show organisers 14 days prior to the event. Show organisers reserve the right to refuse any vehicle entry prior to or on show set up days.
3. Allocation of display space is at the sole discretion of the show organisers. No discussion will be entered into.
4. Entrants will follow direction of show organisers at all times. Failure to follow instructions may result in the vehicle being removed.
5. Entrants warrant to set up and display their vehicles with information and in a condition that meets the general expectation that the event is a "Car Show". We hope owners can be present on their displays to answer any questions from the public.
6. Entrants warrant that any information provided to show organisers is true and accurate to the best of their knowledge. Failure to provide accurate information may result in an application cancellation without refund.
7. The show organisers accept no responsibility whatsoever for any loss, damage, theft or for any other reason of entrants' property, display items or vehicles.
8. Insurance. Entrants are required to have a minimum of Third Party Liability Insurance cover in place for display vehicles.
9. Entrants are liable for any theft, loss, damage or remedy to the venue and or hired items. EG: fluid leak staining/ damage.

10. Vehicle set up must complete by 9.00pm 2 October 2025. Vehicles or displays cannot be removed, covered or disrupted before 4.00pm 2 October 2025.
11. The allocation of awards or prizes for Judged vehicles will be based on Judging sheet results. Judges may or may not be subject matter experts in any category. Results will be final without discussion or protest.
12. No commercial advertising is allowed with entered vehicles unless they appear in conjunction with paid exhibitor space. Any commercial advertising will be removed by show organisers if required.
13. One registration form is required per vehicle entered.
14. Typical car spaces are deemed 18sqm. Spaces larger than 21 SQM may attract a cost. Typical motorbike spaces are deemed 9 SQM. Motorbike spaces larger than 12 SQM may attract a cost.
15. 2 x event passes will be allocated per accepted vehicle. Additional passes are available at a discounted rate of \$15 ea. Maximum of 2 additional passes per vehicle entered. No Pass No Entry.
16. Power points, additional lighting, under car carpet and picket style fencing is available at extra cost. Please contact the show organisers for your requirements.
17. All electrical components used on a car display must be "Tested and Tagged".
18. Any Non-compliant electrical, or any other item, deemed unsafe for any reason will be removed.
19. All display materials including perimeter ropes/ stanchions/ temp fencing etc are at the owners cost and supply.
20. Cancelled applications within 90 days of the event or "No Shows" forfeit the Entry Fee.
21. Any award, prize or monies not claimed and collected by 5.00pm 6 October 2025 will be forfeited.
22. Entrants agree to disconnect car batteries and or a battery master cut off switch is the "Off" position.
23. The vehicle owner, spouse/ partner and guests agree to allow Special Interest Vehicle Events Ltd use of their names and photos for publicity, advertising and commercial purposes before, during, and after the event and without a compensation for use claim.
